This acquisition strengthens Sulzer Chemtech's position as a leading supplier in polymer production systems, with a wide range of technologies for continuous production of polymers. Sulzer's global engineering and manufacturing capabilities, its position as a major enterprise and its global network yield considerable synergies with respect to geographical regions and market segments.

Integration of the acquired business into Sulzer Chemtech will start immediately. The entire staff is retained and will relocate to Switzerland, this way ensuring continuity of the outstanding customer service and product quality for which aixfotec is well known.
